



FINAL CHOICE COLLECTIVE VARIABLE PENSION (CVP) - AT RETIREMENT

You have a pension at Shell Nederland Pensioenfonds Stichting (SNPS) and will be retiring shortly. At that moment you will have to make a final decision for a fixed or a variable pension.

- If you have both gross and net pension at SNPS, you only need to complete one form. Your choice applies to both pension schemes.
- If you only have a net pension at SNPS, this form only applies to your net pension.

Please note: Please ensure we receive your form at least two months before you retire. If you do not choose or do not choose in time, you will be deemed to have chosen to participate in the CVP. You will then receive a variable pension from retirement. This also applies if previously you made a preliminary choice for a fixed pension. You cannot change your final choice(s) after retirement.
