Please use this form if you wish to commence your (part-time) retirement pension at Shell Pensioenfonds Nederland Stichting (SNPS) earlier or later than your official retirement date. With this form, you only inform us of your preferred retirement date. Only when you make your final pension choice(s), you formally request your retirement.

Upon reception of your form, we will send you information about the pension you can expect and the various pension choices at retirement date. The purpose of this information is to help you in making your final pension choice(s). You pension can only commence, two months after we have received you final choice(s). Therefore, please inform us of your preferred retirement date in time.

It is prudent to obtain advice on this matter from a fiscal expert.

Agreements

Part-time retirement is only possible in consultation with the employer. This also applies if you wish to (partially) retire later than your official pension date. In addition, if you are no longer working at Shell Netherlands, and you wish to (partially) retire later, you need to prove that you are still working (part-time) elsewhere. Please send your form at least 6 months, but not earlier than 12 months before your preferred (part-time) retirement date.

Formally requesting your pension

After you have decided to (partially) retire, and after consultation with your employer, you make your final pension choice(s).

Use the SNPS-Final-choice-CVP form at www.shellpensioen.nl under Downloads. Your pension commences at earliest, two months after we have received your final choice(s).

More information

You can find more information in the brochure about pension options and on the website: www.shellpensioen.nl. Do you also accrue pension at Stichting Shell Pensioenfondsen (SSPF)? This does not need to commence at the same date as your SNPS pension.

You need to request commencement of your SSPF pension separately with SSPF.
